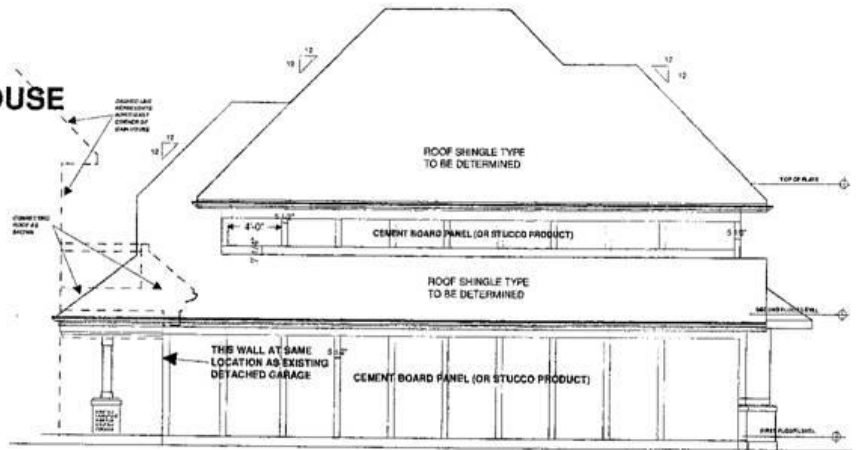

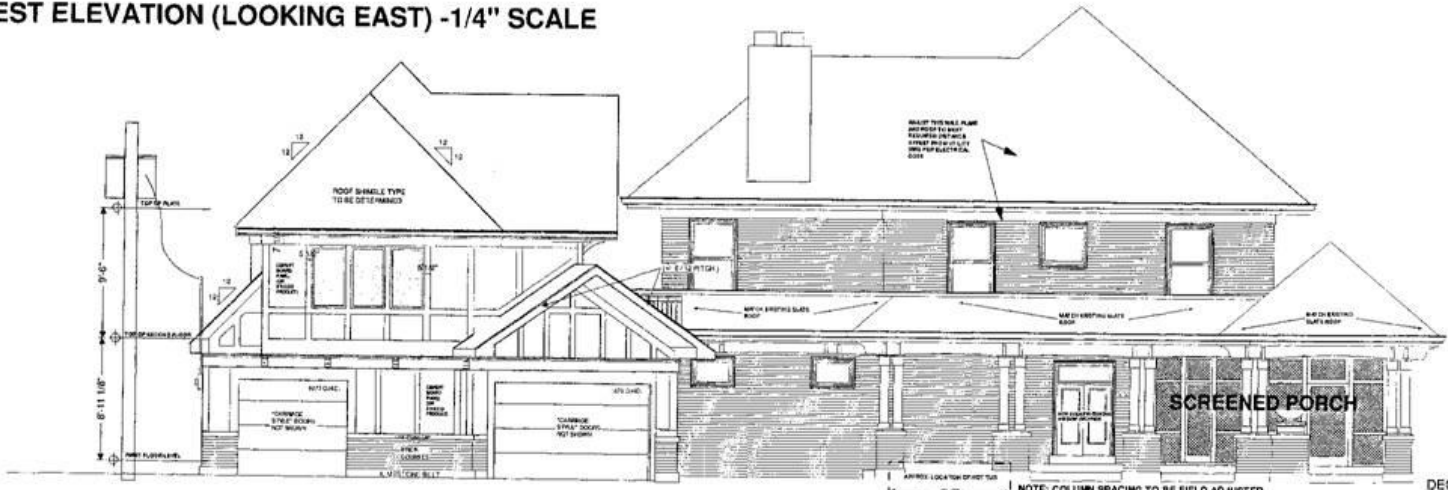
PROPOSED POOL HOUSE

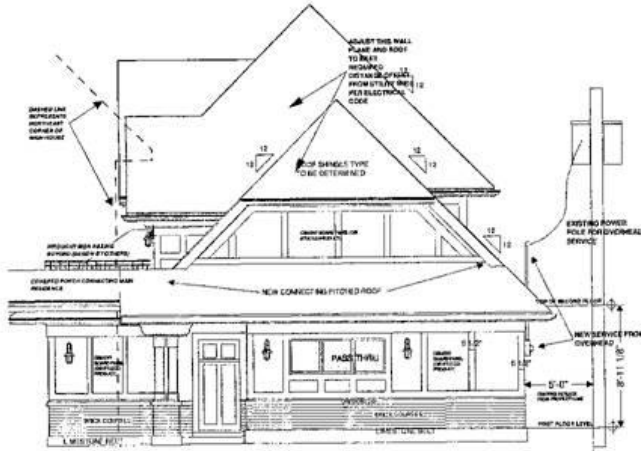

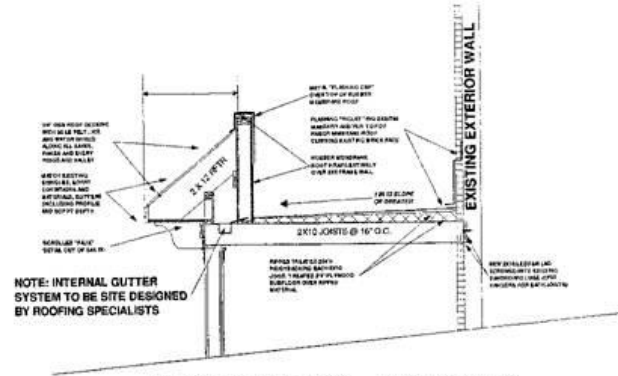


PROPOSED WEST ELEVATION (LOOKING EAST) - 1/4" SCALE

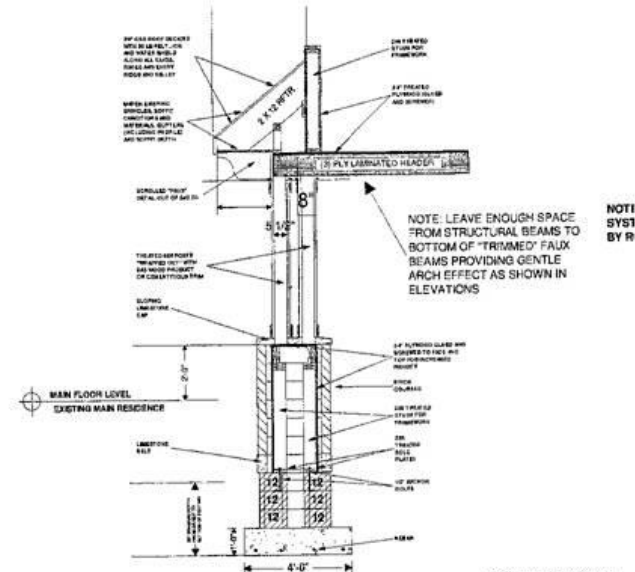
